

Regular Council Meeting
Idalou City Council
April 9, 2018

The regular meeting of the Idalou City Council was called to order by Mayor David Riley. Those in attendance were Mayor Pro Tem Troy Stegemoeller, Joe Sisk, Darrell Fuller, Eric Geiser, and Albert Bravo. Also in attendance was Miguel Guerrero our newest Policeman.

Approval of Regular Minutes from March Council Meeting, A motion was made by Troy Stegemoeller and seconded by Joe Sisk to approve February minutes with the change of Gary Estrada to Jerry Estrada. Motion passed unanimously.
